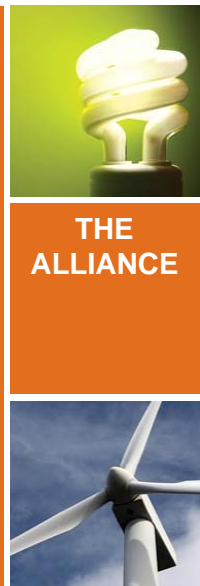

Formed in September 2003

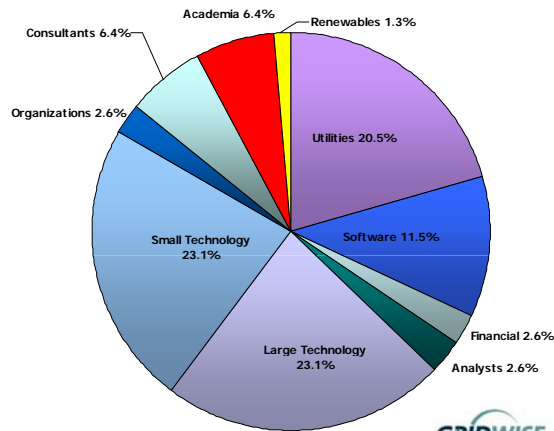
